V. REVIEW AND APPROVE FY21-22 AUDIT REPORT

A. Review

- i. Committee Member Musser asked questions of the auditors.
 - a. The life insurance line item on page 3 of the Audit is a donation from the past.
 - b. There is no line item for realized gain or loss (page 6 of the Audit). The auditors will make this change and re-send the Audit for final approval.
 - c. The auditors explained Note 8 on page 9 of the Audit, explaining there is a semiannual distribution from the Osher Endowment that can be seen in Cash Flow. The total amount will held with The Foundation for California Community Colleges in perpetuity. This is unique to California Community Colleges.
- ii. Rick Alonzo gave a recap of the report, saying it is the cleanest opinion possible.
 - a. Total current assets are high compared with California Community College foundations.
 - b. Donors may look at the Functional Expense percentages. MiraCosta College Foundation has 83% for programs, which is a strength. Typically, program expenses between 65-80% are considered favorable, so the committee noted this could be a marketing tool.
 - c. There will be a separate letter sent to All Governance outlining the risk assessment, for which there were no management letter comments this fiscal year.
